

## INVITATION FOR BIDS

The McKeesport Housing Authority is seeking bids from qualified Contractors for the MHA Radon Mitigation at Scattered Sites located at Scattered Sites, McKeesport, Pennsylvania 15132 until May 8, 2026 at 11:00 AM prevailing time. Bids received after this time shall not be accepted. Bids shall be opened and read aloud thereafter. Bids may be delivered/mailed to the McKeesport Housing Authority, 2901 Brownlee Street, 2nd Floor, McKeesport, PA 15132. The Bids shall be on a lump-sum basis.

All prime bidders are REQUIRED to buy the full set of plans and specifications. Proposals must be upon the forms furnished by the Authority and must be accompanied by a certified check or bank draft, payable to McKeesport Housing Authority, negotiable U.S. Government Bonds (at par value), or a satisfactory bid bond executed by the Bidder and an acceptable surety, in a dollar amount equal to ten percent (10%) of the total bid.
